



(Numbers in millions USD)





Summary of the Paraguayan International Trade

Exports (FOB)

- January 2024: USD 880 million
- January 2023: USD 535 million
- Growth in value: USD 1.9 billion
- Growth in percentage: 19.5%

Countries or trade blocs that mostly impacted on exports growth

- MERCOSUR (USD 343 million)
- ASEAN (USD 8 million)

Products which mostly impacted on exports outcome

- Soy (USD 261 million)
- Soy flour (USD 31 million)

Imports (CIF)

- January 2024: USD 1.4 billion
- January 2023: USD 1.3 billion
- Growth in value: USD 151 million

- China (USD 62 million)

Products which mostly impacted on imports outcome

- Electric machines and devices (USD 46 million)
